2. 1 Company Overview

Manasvi Capital Pvt. Ltd. (the Company) is a private limited company domiciled in India and incorporated under the provisions of Companies Act, 2013. The Company is a Non Deposit Accepting Non-Banking Financial Companies (NBFC) registered with the Reserve Bank of India (RBI) with effect from January 19, 2021 with Registration No. B-10.00313. The Company is engaged in the business of lending and primarily deals in financing of two and three-wheelers, consumer durables, small business loans, personal loans, mortgage loans etc.

2 Significant Accounting Policies

2.1 Basis of preparation of financial statements:

The financial statements have been prepared to comply in all material respects with the notified accounting standards as prescribed under section 133 of the Companies Act, 2013 ("the Act") read with Rule 7 of the Companies (Accounts) Rules, 2014, the provisions of the Act (to the extent notified) and Master Circular - "Non-Systemically Important Non-Banking Financial (Non-Deposit Accepting or Holding) Companies Prudential Norms (Reserve Bank) Directions, 2015" issued on July 01, 2015, and updated as on April 04, 2016, by RBI. The financial statements have been prepared under the historical cost convention on an accrual basis in accordance with accounting principles generally accepted in India. The Accounting policies adopted for the preparation of financial statements are consistent with those followed in previous years.

All assets and liabilities have been classified as current and non-current as per the criteria set out in Schedule III to the Companies Act, 2013. Based on the nature of the products and services and the time between acquisition of assets for processing and their realisation in cash and cash equivalents, the Company has ascertained its operating cycle as 12 months for the purpose of current/non-current classification of its assets and liabilities, except for receivables considered doubtful, which are shown as non-current.

2.2 Use of Estimates :

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent liabilities at the date of the financial statements and the result of operations during the reporting period end. Although these estimates are based upon management's best knowledge of current events and actions, actual results could differ from these estimates. Significant estimate used by the management in the preparation of these financial statements include estimates of the economic useful lives of fixed assets, provisions for bad and doubtful debts.

Accounting estimates could change from period to period. Appropriate changes in estimates are made as the management becomes aware of changes in circumstances in surrounding the estimates. Changes in estimates are reflected in the period in which changes are made and, if material, their effects are disclosed in the notes to the financial statement. Any revision to accounting estimates is recognized prospectively.

2.3 Cash Flow Statement (AS-3)

The Cash Flow Statement has been prepared under the "Indirect Method" as set out under para 18 of Accounting Standard 3 on Cash Flow Statement issued by the Institute of Chartered Accountants of India.

2.4 Prior Period Items (AS-5)

Prior period items are income or expenses which arise in the current period as a result of errors or omission in the preparation of the financial statements of one or more prior periods.

2.5 Fixed Assets & Depreciation (AS-10, AS-6)

Fixed assets are stated at cost less accumulated Depreciation and impairment if any. Depreciation is provided on Straight line method (SLM) based on useful life as specified in Part 'C' of Schedule II of Companies Act 2013 after retaining residual value of 5%. The Company provide pro-rata depreciation from/to the date on which the asset is acquired or put to use/disposed as appropriate. Depreciation is computed till the date of sale of asset. Depreciation methods, useful lives and residual values are reviewed periodically, including at each financial year end.



2.6 Revenue Recognition (AS-9)

Revenue from Operations

Interest, finance charges, service charges etc. are recognised as income on accrual basis with reference to the terms of contractual commitments such as interest subsidy and finance agreements entered into with borrowers, as the case may be, except in the case of delinquent assets provided for, penal, dishonour, foreclosure charges etc., where income is recognised on realisation basis.

Revenue from Investments

Interest on securities is accounted for on accrual basis except where the ultimate collection cannot be established with reasonable certainty.

Revenue from Non-Performing Assets

Income from Non-Performing Assets (NPAs) including investments, as per the prudential norms prescribed by RBI

2.7 Transactions in foreign currencies (AS-11)

All transaction in respect of foreign currencies are recorded at exchange rate prevailing on the date of the transactions. All monetary assets and liabilities in foreign currency are restated at the end of accounting period, using closing rate. Exchange differences on restatement/settlements of monetary items are recognized in the Statement of Profit & Loss.

2.8 Investments (AS-13)

Investments that are intended to be held for more than a year, from the date of acquisition, are classified as long term investments and are carried at cost. However, provision for diminution in value of investments is made to recognize a decline, other than temporary, in the value of investments. Investments other than long term investments being current investments are valued at cost or fair value whichever is lower, determined on an individual basis. Investment properties are valued at cost.

2.9 Employee Benefit : (AS-15)

i) Short term employee benefits are recognized as an expense at the undiscounted amount in the profit and loss account of the year in which the related service is rendered. Employee benefits such as PF, ESI etc. are treated as defined contribution plan and contributions are charged to P&L A/c when contributions to the respective funds are due.

ii) Post employment and other long term employee benefits are recognized as an expense in the Profit & Loss A/c of the year in which the employee has rendered services and treated as defined benefit plans. The expenses are recognized on the assumption that such benefit are payable at the end of the year to the eligible employees.

2.10 Borrowing Cost (AS-16)

Borrowing costs that are attributable to the acquisition or construction of qualifying assets are capitalised as part of the cost of such assets. A qualifying asset is one that necessarily takes substantial period of time to get ready for its intended use. All other borrowing costs are charged to the Statement of Profit and Loss in the period in which they are incurred.

2.11 Earning Per Share :(AS-20)

The earning considered in ascertaining the company's earning per share comprises the Net Profit/Loss for the period attributable to Equity Shareholders. The number of share used in computing basic earning per share is the weighted average number of share outstanding during the year.

Income taxes are accrued in the same period that the related revenue and expenses arise. A provision is made for income tax liability computed, after considering tax allowances and exemptions. Provisions are recorded when it is estimated that a liability due to disallowances or other matter is probable. Minimum Alternate Tax (MAT) paid in accordance with the tax laws, which gives rise to future economic benefits in the form of tax credits against future income tax liability, is recognised as an asset in the Balance Sheet if there is a convincing evidence that the company will pay normal tax in near future.

Income-Tax expense comprises current tax and deferred tax charge or credit. Provision for current tax is made on the basis of the assessable income at the tax rate applicable to the relevant assessment year. The deferred tax asset and deferred tax liability is calculated by applying tax rates and tax laws that have been enacted or substantively enacted by the balance sheet date. Deferred tax assets arising mainly on account of brought forward losses and unabsorbed depreciation under tax laws, are recognized, only if there is a virtual certainty of its realization, supported by convincing evidence. Deferred tax assets on account of other timing differences are recognized only to the extent there is a reasonable certainty of its realization. At each Balance sheet date, the carrying amounts of deferred tax assets are reviewed to reassess amount.

2.13 Impairment Of Assets (AS-28)

The Carrying amounts of assets are reviewed at each Balance Sheet date if there is any indication of impairment based internal/external factors. An asset is impaired when the carrying amount of the asset exceeds the recoverable amount. An impairment loss is charged to the Profit and Loss account in the year in which an asset is identified as impaired. An impairment loss recognized in prior accounting periods is reversed if there has been change in the estimate of the recoverable amount.

2.14 Provisions, Contingent Liabilities and Contingent Assets (AS-29)

Provisions are recognized for liabilities that can be measured only by using a substantial degree of estimation, if

- a) the Company has a present obligation as a result of a past event.
- b) a probable outflow of resources is expected to settle the obligation and
- c) the amount of the obligation can be reliably estimated.
- d) Reimbursement expected in respect of expenditure required to settle a provision is recognized only when it is virtually certain that the reimbursement will be received.

2.15 Receivables under financing activity and provisioning/write-off of Assets

Receivables under financing activity represent principal and matured finance charges outstanding at the close of the year but net of amount written off.

The provisioning/write-off on overdue assets is as per the Management estimates, subject to the minimum provision required as per the NBFC Master Directions.

The Company assesses all receivables for their recoverability and accordingly makes provisions for non-performing assets (NPAs) and delinquent assets not yet NPAs as considered necessary including by accelerating provision to an early stage based on past experience, emerging trends and estimates which is disclosed under 'Short-term provisions' in note no.5 to the financial statements. However, the Company ensures that the said provisions are not lower than the provisions stipulated in the NBFC Master Directions.

Contingent provision against standard asset, as required by the NBFC Master Directions, is also made by the Company on the standard assets outstanding which is disclosed under 'Provisions' schedule to the financial statements.

2.16 General

Except where stated, accounting policies are consistent with the generally accepted accounting principles and have been consistently applied.

The previous year figures have been reworked, regrouped, rearranged and reclassified wherever necessary. Accordingly amounts and other disclosure for the preceding years are included as an integral part of the current year financial statement and are to be read in relation to the amounts and other disclosure relating to the current year.

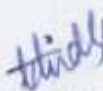
